TERMS AND CONDITIONS

YOU ARE A VALUED CUSTOMER OF REVEL RIDES LLC AND WE WANT YOU TO ENJOY YOUR USE OF OUR VEHICLE. WE WANT TO ENSURE THAT THE INTEGRITY OF OUR VEHICLE IS MAINTAINED.

Therefore, these rules apply to all transportation (special events, weddings, proms, etc.) provided by Revel Rides LLC without exception. Failure of customer to comply with these rules and regulations will result in termination of service, requiring payment in full with no refund.

-Revel Rides LLC will strictly enforce State and Federal Laws and will maintain a zero tolerance compliance policy. No alcoholic beverage can be consumed or used by any person **less than 21 years of age**. All U.S. law enforcement agencies have absolute power to stop any motor vehicle for administrative search. Therefore no person will bring contraband aboard vehicles that is owned and operated by Revel Rides LLC.

-Revel Rides LLC will not be responsible for injuries that may occur due to horse playing or standing while the vehicle is in motion, at a standstill or entering and exiting vehicle. The purchaser on the front of this contract is responsible for his or her guests.

-Revel Rides LLC recommends that all and any personal values be removed from the vehicle when unattended. We will not be responsible for any lost, stolen, or damaged property.

-Revel Rides LLC reserves the right to terminate this contract for noncompliance of the provisions and/or the renter’s failure to comply with the chauffeur’s requests or instructions.

-Revel Rides LLC will require proof of legal possession of the credit card provided.

-Revel Rides LLC cannot guarantee the availability of overtime. Any overtime agreed upon will be charged at stated contract rate. Overtime will be rounded up to the nearest half hour.

ADDITIONAL RULES

1. No alcohol may be consumed by anyone under 21 years of age.
 - a. All minors must be accompanied by their guardian if alcohol is consumed in the vehicle. Violation may result in early termination with no refund.
2. NO SMOKING inside the vehicle. This will result in a \$100.00 charge per incident. No exceptions.
3. Clean up fee for vomiting in the Revel Rides vehicle will be assessed at \$300 or 125% of actual cleaning and/or repair cost.
4. No shoes are allowed on the upholstery.
5. No illegal drug use of any kind is permitted
6. A \$100.00 fee will be charged for excessive matter left in vehicle including, but not limited to: glitter, spilled drinks, chips and decorations.
7. All unruly persons will be dropped off at the sole discretion of the driver with no refunds.
8. Customer agrees that a replacement vehicle may be substituted in the event of any major mechanical issues or accident etc. If a replacement vehicle is not available a refund of the balance of the time remaining will be mailed to you.
9. The person who signs this contract will be responsible for all damages. Damages will be charged at 125% of repair costs, including but not limited to gum, food, or drink spills.
10. All persons must be seated at all times while the vehicle is in motion. Revel Rides LLC is not liable for injuries to guests who are not seated during transit.
11. A 20% gratuity is added to the hourly rate and is part of total contract price.
12. Non-sufficient fund payments, cancelled checks or withdrawn payments are subject to a \$25 fee. NSF payments plus service charge is due within 3 days or are subject to prosecution to the fullest extent of the law.

Due to extreme size of vehicles driver may not be able to enter requested destination due to congestion and/or clearance (i.e. crowded parking lots, steep inclines, large dips, dirt roads, etc.). Drivers will do their best to get as close as possible to the desired location.

I have read and agree to the terms of this contract. I understand and agree to the length and usage, and agree to pay for any and all damages my party may cause during the rental period. I also agree to the above Limousine Rules and Regulations. I understand and agree to pay the entire contract price if cancellation policy is not followed.
